

## Florida Poly HEERF January - March 2022 Quarter Report

To comply with Section 18004(e) of the CARES Act and submit a report every 45 days after the initial report (the “30-day Fund Report”), then quarterly based on guidance from the US Department of Education, Florida Polytechnic University is following the guidance announced in the [Federal Register Notice](#) by reporting the following information listed below.

1. *Florida Polytechnic University signed and returned to the Department the Certification and Agreement and intends to use no less than 50 percent of the funds received under Section 18004(a)(1) of the CARES Act, CRRSAA, and ARP(a)(1) programs to provide Emergency Financial Aid Grants to students.*
  
2. The total amount of funds that the institution will receive or has received from the Department pursuant to the institution’s Certification and Agreement [for] Emergency Financial Aid Grants to Students under the CARES Act, CRRSAA and ARP(a)(1) programs.
  - *HEERF I: Florida Polytechnic University received \$626,652 to be used for Emergency Financial Aid Grants to students from the CARES Act.*
  - *HEERF II: In January 2021, Florida Polytechnic University received another \$626,652 to be used for Emergency Financial Aid Grants to students from the Coronavirus Response and Relief Supplemental Appropriations Act of 2021 (CRRSAA). Florida Poly draws these funds as we disburse to students.*
  - *HEERF III: In May 2021, Florida Polytechnic University received another \$1,621,781 to be used for Emergency Financial Aid Grants to students from the grant authorized under ARP(a)(1). The first draw from the ARP funds was September 2021 (after HEERF II funds were exhausted).*
  - *Total Combined received/will receive = \$2,875,085*

  - *HEERF I: Florida Polytechnic University has distributed all of the \$626,652 of the CARES Act funds to 834 students.*
  - *HEERF II: Florida Polytechnic University has distributed all of the \$626,652 of the CRRSAA funds to 461 students.*
  - *HEERF III: As of 3/31/22, Florida Polytechnic University has distributed \$1,146,588.53 of ARP(a)(1) funds to 604 students*
  - *Total combined distributed = \$2,399,892.53 for 1195 unduplicated students*

4.   - *HEERF I: Florida Polytechnic University has distributed all CARES Act funds to 834 students.*
  - *HEERF II: Florida Polytechnic University has distributed all CRSAA funds to 461 students.*
  - *HEERF III: As of 3/31/22, Florida Polytechnic University has distributed CRSAA funds to 604 students.*
  - *Total Combined Students (unduplicated) = 1195*
  
6. The method(s) used by the institution to determine which students receive Emergency Financial Aid Grants and how much they would receive under Section 18004(a)(1) of the CARES Act, CRRSAA and ARP(a)(1) programs.

*Distribution methods include an application system, as well as an equity model for a group of students with eligible FAFSA on file.*

  - *HEERF I:*
    1. *Application system - Students submit an application requesting funding for expenses that have incurred as a result of COVID19. Students also provide a written explanation and supporting documentation. Applications are then reviewed by the Office of Financial Aid. Approvals, denials, or requests for more information are emailed to the applicant. Approved amounts are added in CAMS (the University's SIS) to the student's account, the refunded directly to the student via BankMobile. Students can apply each semester (until the fund is exhausted). Amounts for each expense have guidelines and the maximum amount a student may apply for over the year is \$6195.*
    2. *Equity model - The University distributed an equal amount to federal aid eligible*

*students continuing their education to assist with any financial hardships or added expenses that could occur as a result of classes going remote after Thanksgiving break, as well as a safe return to campus in spring. To qualify the students had to have an eligible FAFSA on file and had to have registered for spring by November 20th to qualify. The figure per student was determined based on remaining funds, but still allowing some funds to remain for spring under the application system should students continue to be in need. \$247,401 was divided equally among the 693 students that met the criteria and distributed on 11/23/20 (\$357 each).*

- *HEERF II and III: The same application system is in place for HEERF II and III. In addition, we used equity models.*
    - *An email was sent to 415 students with EFCs 5711 or less. The deadline for this group of students to accept the award of \$1100 was April 23, 2021. 328 students accepted their award.*
    - *An email was sent to 501 students with EFCs 5846 or less. The deadline for this group of students to accept the award of \$1100 was September 30, 2021. 379 students accepted their award.*
    - *An email was sent to 189 loan borrowing students who had not received HEERF yet in the fall 21 semester. The deadline for this group of students to accept the award of \$1000 was December 13, 2021. 97 students accepted their award.*
    - *An email was sent to 443 students with EFCs 5846 or less. The deadline for this group of students to accept the award of \$1600 was March 11, 2022. 361 students accepted their award.*

    2. *Equity model - Eligible students were notified on 11/3 via email with instructions that they needed to have registered by November 20th for spring classes to qualify for the automatic disbursement and that funds were to be used to assist with any financial hardships or added expenses as a result of classes going remote after Thanksgiving and returning safely back to campus in spring.*
